


Future orders are not tied to specific encounters, so order on the clinic encounter for the same day should have the future order field filled as No.

Not Scheduled may not be available on certain radiology exams (example: XR).

Physician enters diagnosis code and associates it with the order and the diagnosis description populates in the RFE Field.

Medicaid Promoting Interoperability: More than 60% of radiology orders created by the EP are recorded using CPOE. Professional fee captured via order.
