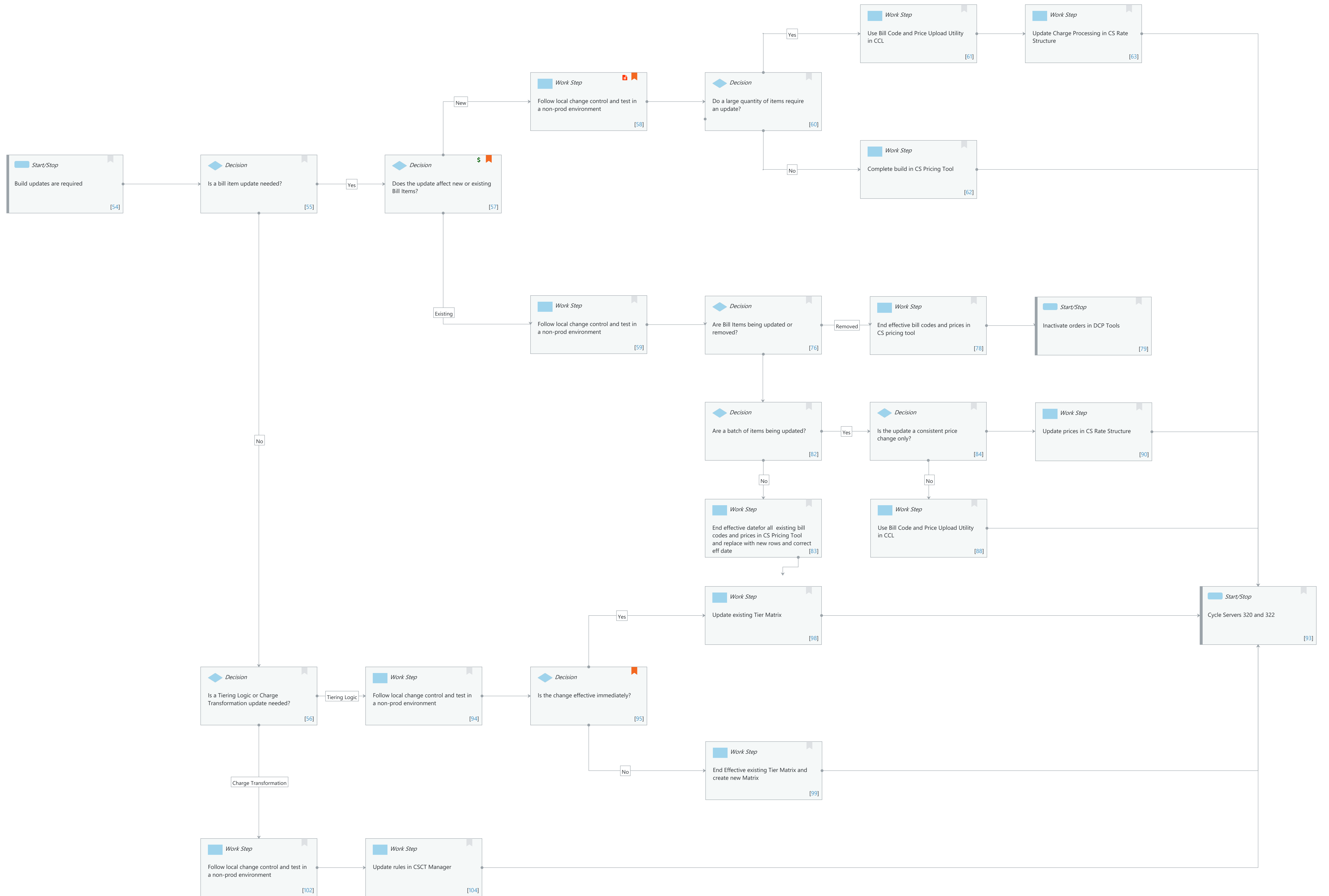

If you update the existing matrix, you are accepting that the system will correct charges historically when encounter modifications are completed.
