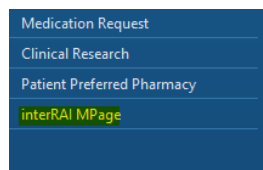
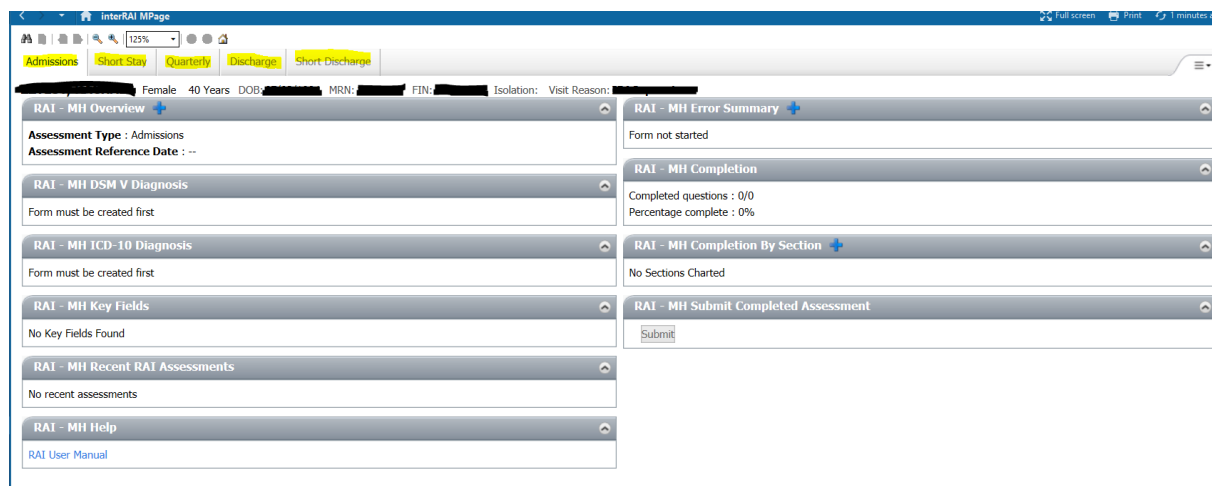


RAI ASSESSMENTS

Residential Assessment Instrument (RAI) will be accessed through a custom Mpage located on the blue vertical bar on the MHA Inpatient Nursing and Psychiatrists positions. (interRAI Mpage)

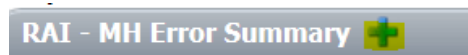


Within the Mpage, there are tabs with the specific assessments to complete. In order to document on the correct assessment, select the tab that relates to the assessment that is due for the patient. If you select the wrong tab/powerform, you must redo the assessment on the proper tab/powerform.



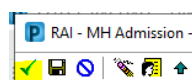
NURSING

To access the powerform, select the + sign next to RAI-MH Error Summary



Form not started

Always ensure that the powerform is signed not saved so that other clinicians can see what was documented and completed.



RAI Mpage will show all errors on the powerform according to CIHI (OMHRS) requirements. This form cannot be submitted until all errors are fixed and completion percentage is at 100%. Edits to this powerform MUST be completed until the submit button is selected by clicking on the + sign.





PSYCHIATRIST

Medical diagnosis and Psychiatric diagnosis must be entered in two locations for inpatient mental health patients, diagnosis and problems component in the blue vertical bar (SNOMED) and interRAI Mpage in the blue vertical bar (ICD10/DSM5)




Psychiatrist to enter diagnosis under the correct tab for the assessment being completed. (Admission/Short Stay/Quarterly/Discharge/Short Discharge)



Diagnosis component will only become available once a clinician has started the form. If a psychiatrist cannot enter a diagnosis because a form has not been started, they could start the form by clicking on + sign beside RAI-MH Error Summary. They would need to select Unit at time of this assessment and click on green checkmark to sign.



ICD10/DSM5 diagnosis component will allow search of a diagnosis. Ensure you change the filter to contains if you do not know the exact name of the diagnosis



Once a diagnosis is selected, only the ICD10/DSM5 code will show below the component not the whole diagnosis description.
