

The following recommendations are based on the Model Experience standard configuration: Require the minimum number of elements to allow the patient to be added quickly to the ED Tracking Board. Facilities must have local policies in place for naming conventions when patients cannot identify themselves on arrival. According to the Emergency Medical Treatment and Active Labor Act (EMTALA), anyone coming to an emergency department must be stabilized and treated regardless of their insurance status or ability to pay.
