	Coding Pass on Task Workflow.

With the Coding (Pass on Task) workflow, coders save a task as a draft and select an

appropriate pass reason, which updates the task to an On Hold status. Certain pass reasons automatically update when providers complete documentation, which notifies coders that they can finalize coding. This eliminates the need for coders to have to manually look in PowerChart to see if the documentation has been completed yet or not.

Pass reasons associated with work items send Discern notifications to clinical personnel when charge correction is needed. Discern notifications serve as a communication tool which eliminates the need for calling and emailing among departments. This streamlines the charge correction process so that coders can finalize coding more quickly.

This workflow also includes a process for manager review, peer review, and training review. These pass reasons and task queues

should be used for new hires when they have coding questions that need to be answered before being able to finalize coding. This assists with reducing the chances of receiving denials due to inaccurate coding.
