HIM specialists use analysis task queues in Patient Deficiency Analysis to identify encounters to be reviewed for missing documents. For any encounters with missing documents, deficiencies are assigned to the appropriate physician based on a list of predefined deficiency documents. These deficiencies are displayed as anticipated documents in the physician's Message Center. When a deficiency is resolved, the deficiency status is updated automatically in Patient Deficiency Analysis. Deficiency analysis allows for timely and accurate coding and billing, and ensures the medical record is complete in accordance to regulatory requirements.
