

	Combine Encounter Workflow.

The Combine Encounter workflow uses Combine to combine two encounters into a single encounter. If two encounters were registered for the same services on the same day, the encounters need to be combined using the Combine Encounters functionality in Combine. It is crucial for organizations to maintain their EMPI and combine duplicate encounters so patient safety and record integrity are not compromised.

If the HIM coder finalized coding

on the surviving encounter before the encounters were combined, a HIM Coding - Combines task is added to the coding task queue. The coder must save coding on the surviving encounter again, because grouper information is erased during the encounter combine process. It is important to save coding as final again because missing grouper information can result in denials or rework, as well as inaccurate case mix index reporting. Additionally, since clinical documentation is moved during an encounter combine, codes may need to be added or modified, which can impact grouper information and

#### Work Step [4]

Description: Review each encounter's information to confirm a combine is necessary

## **Decision** [5]

Description: Does an encounter combine need to occur for the identified encounters?

### Start/Stop [11]

Description: Do not perform the combine, and contact who it was reported by to clarify

#### Work Step [6]

Description: Within HNA Combine, determine which encounter is the "surviving" encounter (Encounter A or B)

#### Work Step [7]

Description: Perform the encounter combine by selecting "A into B" or "B into A" Comments: The incorrect encounter should be moved/combined with the master/ surviving encounter. For example, if the incorrect encounter is



encounter A and the master/surviving encounter is encounter B, then A should be moved to B.
