

Comments: Opioid Treatment Agreements typically include specific patient education acknowledgements and communicate to the patient the expectation of certain risk mitigating steps, such as random urine drug screenings

#### System [36]

Description: "Opioid Dependence with Current Use" added to the Problem List Method: Problem List

Comments: This step is optional. The functionality is provided by a Discern Expert Knowledge Module (rule) BCC\_OPIOID\_TXAGT\_PRBLM. Each organization should evaluate whether this is appropriate for their patient population (e.g. this is appropriate if all patients in Opioid Treatment Agreements are chronic users of opioid medications, but otherwise may not be clinically accurate).
