

## Decision [64]

Description: Is the patient being discharged from program ?

## Decision [29]

Description: Is the person still opioid dependent?

Comments: "Opioid dependent" means that the person is still susceptible to experiencing acute withdrawal symptoms if their opioid medication were abruptly discontinued (e.g. without tapering). This is a physiological response to long-term of certain substances, including opioids, but does not inherently refer to addiction / substance use disorder (i.e. a person can be dependent and not be experiencing addiction).
