

Description: Will you administer the medication to the patient at this time or within an appropriate timeframe?

# Work Step [73]

Description: Obtain and prepare medication or continuous infusion.

# Work Step [72]

Description: Select appropriate medication task from patient MAR.

#### **Decision** [74]

Description: Does the pharmacy verification or rejected by pharmacy warning present to user?

#### Decision [75]

Description: Is it appropriate per hospital policy to continue with administration? Step Impact: Policy/Procedure

## Start/Stop [83]

Description: Wait for pharmacy to verify medication order. Restart process.

## Decision [62]

Description: Does medication task need to be rescheduled?

## Start/Stop [65]

Description: Right click on medication task and select Reschedule. Reschedule task to new time, select appropriate reason, and select OK.

## Decision [85]

Description: Are there any additional charting requirements? Value Impact: Patient Safety

## Work Step [86]

Description: Document, Acknowledge, or adjust required charting fields.

# Start/Stop [64]

Description: Right click on medication task and select Not Done. Chart appropriate reason and select the green checkmark.
