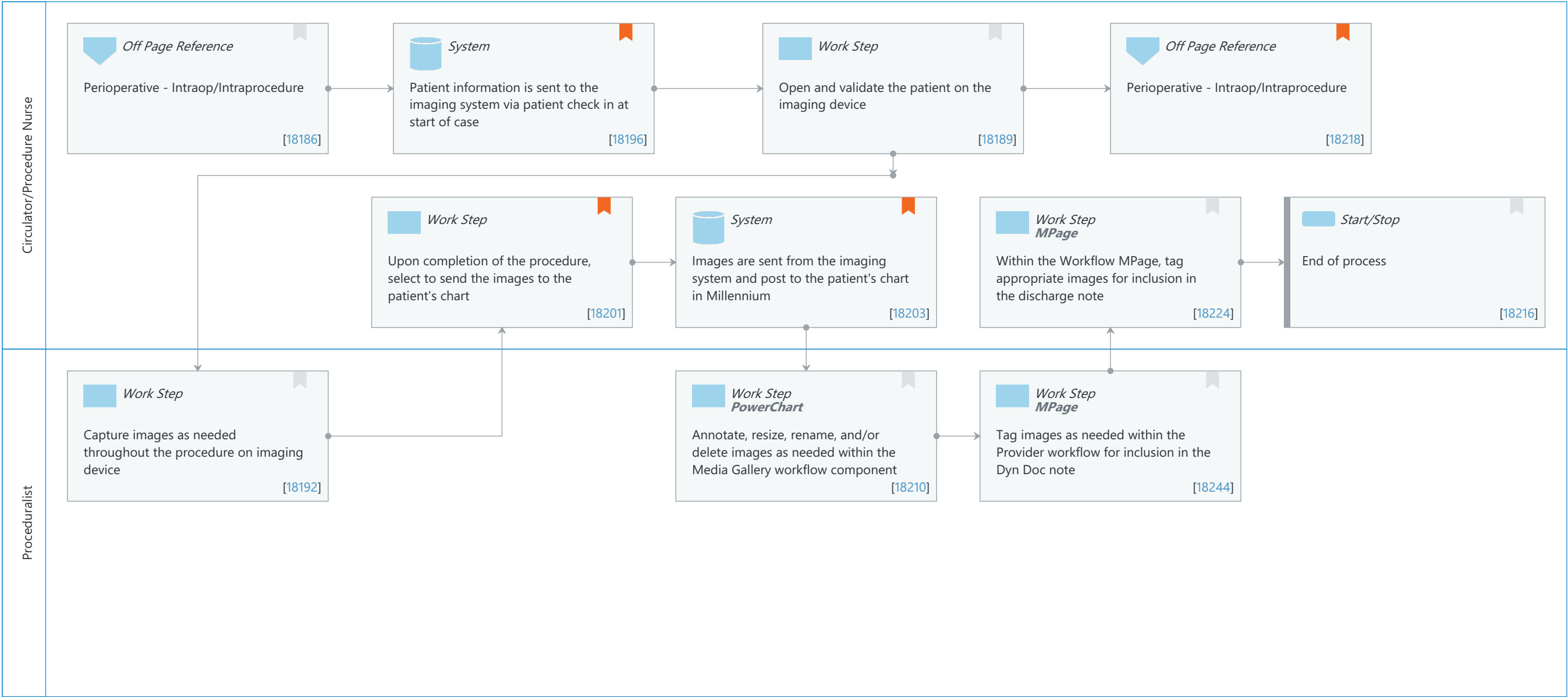

**Work Step [18201]**

Description: Upon completion of the procedure, select to send the images to the patient's chart

Comments: Typically, the nurse will simply send the full list of images into Millennium (this is almost exclusively true for GI cases as the physician typically needs to get to their next procedure quickly). However, there could be instances for a surgical imaging case where the surgeon may want to review the images in the imaging system and delete any unwanted images before sending them to Millennium.

**System [18203]**

Description: Images are sent from the imaging system and post to the patient's chart in Millennium

Comments: Images are sent from the imaging system into a network file share, and are then retrieved via Cerner's Batch Prep service and made to be viewable within the Clinical Media (MultiMedia Manager) chart component in PowerChart. The process is near real-time, typically taking up to a minute.
