Work Step [4]

Description: From the Inpatient Workflow Mpage, navigate to the Home Medications component and click "Transfer"

Work Step [5]

- Description: Review all orders, and select which to continue in the next level of care and which to stop.
- Comments: The Transfer Reconciliation window presents an opportunity to reconcile additional order types aside from medications. This allows the sending prescriber to make recommendations for multiple types of orders that they suggest be continued/not continued in the patient's next level of care.

Decision [7]

Description: Transfer reconciliation completed?

Work Step [11]

Description: Not recommended: Reconcile and Plan.

Comments: Prescribers are only advised to use the plan med rec functionality if their work gets interrupted and they need to come back to this window. Otherwise, always hit the Sign button.

Work Step [10]

Description: Reconcile and "Sign"

Description: Transfer reconciliation status displays a partially completed icon.

Description: Was the Transfer Reconciliation completed prior to the transfer by sending prescriber?

Comments: Ideally, the sending prescriber should always complete the transfer

To understand if a Transfer Reconciliation has been completed by the sending prescriber, review the Reconciliation History section on the Order Profile.

Work Step [58]

Description: From the Inpatient Workflow Mpage, navigate to the Home Medications component and click "Transfer"

Work Step [63]

Description: Reconcile orders (Add/update any applicable orders)

Decision [44]

- Description: Are the orders that were continued by the sending prescriber applicable for the new level of care?
- Comments: The sending prescriber completes the transfer reconciliation for patient care recommendations in their receiving unit. The receiving prescriber reviews the order recommendations via the Reconciliation History section of the Order Profile and makes adjustments as needed in the Transfer Reconciliation window. This is a collaborative effort.

Work Step [13]

- Description: Review all Active orders on the Order Profile and add/update any applicable orders
- Comments: The Merge functionality can be useful when reviewing existing orders on the profile and placing new orders via an order set.

Start/Stop [18]

Description: Reconcile and "Sign"/Sign orders

Work Step [46]

Description: Discontinue orders that may not be applicable based on clinical judgement

Comments: Prescribers can discontinue the existing Powerplan and place a new appropriate Powerplan for the level of care, or prescribers can pick and choose individual orders that are not appropriate and only discontinue those.
