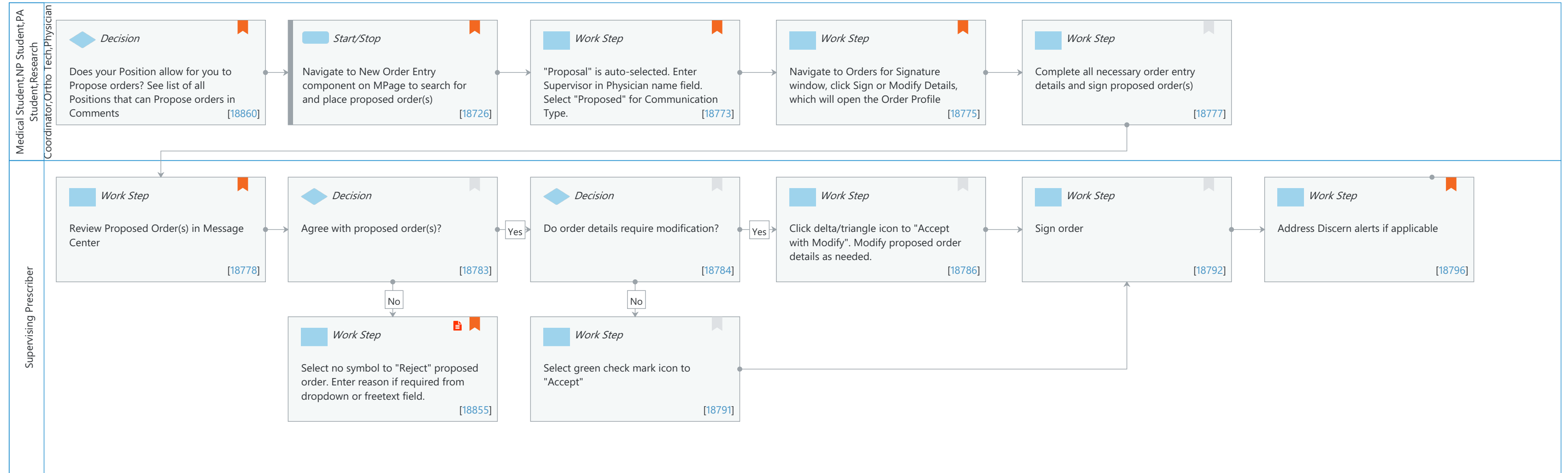

Comments: Best to be used if not time-sensitive when need immediate action.

Difference between proposed orders and orders for cosignature: proposed orders will not become active on the chart until the Supervising Prescriber signs off on them. Orders for cosignature are active upon original signing.

Follow up: Physician Assistant- exception privileges for narcotics for proposed orders

**For follow up with Professional Practice: Policies are needed for types of orders that can be proposed and roles that can propose orders. Additional role examples could include wound care nurse,

Ortho tech may propose x-ray and then cast removal; RN may propose Rx renewal.

Consultants shouldn't use the Proposed Order workflow. If the MRP doesn't want the consultant to make orders active on their patients, the consultant can be taught to communicate their order requests to the MRP through detailed suggestions in their Consult Note.

Work Step [18773]

Description: "Proposal" is auto-selected. Enter Supervisor in Physician name field. Select "Proposed" for Communication Type.

Comments: Order radio button is greyed out automatically for the Student/ Research Coordinator positions.

Work Step [18775]

Description: Navigate to Orders for Signature window, click Sign or Modify Details, which will open the Order Profile

Comments: In the Orders for Signature window, select the Sign button if all of your order details are already complete (i.e. you don't need to modify the order any further)

Description: Complete all necessary order entry details and sign proposed order(s)
