


Comments: SIRS alerts are suppressed for 24 hours and Sepsis alerts are suppressed for 48 hours. If a SIRS alert fires, a Sepsis alert can still fire within the 24 hour period, but not an additional SIRS alert. This is to prevent over-alerting and allow time for interventions to change patient disposition
